

# Call for Papers

The Business and Applied Sciences Academy of North America (BAASANA) is an interdisciplinary, not for profit, professional association of business, sciences, and technology. It seeks dissemination of advanced knowledge and skills among scholars and practitioners of business and applied sciences toward resolving issues and problems of the 21st century. By sharing knowledge, expertise, and facilitating transfer of know-how across the digital divide, BAASANA programs seek to contribute toward improvement of human conditions.

The first BAASANA conference was held during the summer of 2009 in Philadelphia. In the subsequent years, the conference was held in the different parts of North America. Considering the convenience of the international participants, Foreign Trade University in Ha Noi, Vietnam was selected as the site of BAASANA 2018 International Conference, organized by the BAASANA and Foreign Trade University.

The International Conference of the Business and Applied Sciences Academy of North America (BAASANA) will be held during May 15-17, 2018 at Foreign Trade University, 91 Chua Lang Street, Dong Da District, Ha Noi, Vietnam.

Scholarly papers, abstracts, proposals for panel from all academic and applied disciplines in business, natural, social, behavioural sciences including fields of applied humanities such as journalism, mass communication, law and legal studies, educational administration health sciences, engineering and IT technologies are being invited for presentation at the conference. The paper Submission Deadline is March 15, 2018. Earlier submission is highly encouraged.

Since visa formalities and travel arrangements could take months, international participants are advised to submit paper, abstracts, and panel proposals ASAP. An acceptance letter will be sent following an expedited peer review process. BAASANA publishes proceedings of conferences at <a href="https://www.baasana.org">www.baasana.org</a>. Our annual proceedings are submitted to Google Scholars for indexing in addition to the U.S. Library of Congress ISSN: 2471-6847. Proceedings for the 2018 International Conference in Viet Nam will be published in October, 2018 and it will be submitted for indexing by Thompson Reuter in November-December 2018.



#### **Submission Guidelines:**

- 1. Paper/Abstract: Submit a complete paper (page limit: 20 double spaced pages including tables, references) or an abstract up to 250 words (the title, authors' name, address, and email address) via online via www.baasana.org or BAASANA@bloomu.edu
- 2. Proposal for a Panel Discussion (for Practitioners only 60-90 minute session): Submit 300-500 words with a title, indicating the track names. The Chair takes the responsibility of summarizing the discussion for publication in the proceedings.
- 3. Only electronic submission via the link above of a Microsoft word document is accepted. The "Best Paper" in each track will be recognized in the Conference at the conference Banquet.






#### Conference Registration:

At least one author of accepted papers, abstracts, panel proposals will be required to register and attend the conference.

Early bird registration fee (payable by April 15, 2018 or within 2 weeks of the receipt of acceptance letter) is as follows:

- Participants from developed countries: \$US300
- Participants from developing countries: \$US200
- Participants from Vietnam: \$100
- Student participants: \$US75

Regular registration fee after April 15 is \$US350, \$US250, \$US150, and \$US125 respectively. To be included in the conference program, all participants must be preregistered the conference by April 30, 2018.


